 - Inclusion of new clause to clarify Legal Aid Queensland's rights when investigating complaints or notification matters: to suspend new referrals, re-allocate existing matters as allowed under clause 4.10 a, and/or direct that a relevant person not undertake legal aid work under clause 4.14 b.

 - Addition of paragraph C to require notification of a serious or systemic confidentiality, privacy or data breach.
 - Consequential lettering changes to paragraphs D to O.
 - Addition of paragraph P to require notification of any other matter which adversely affects or could be reasonably expected to adversely affect the conduct of legal aid work or Legal Aid Queensland's financial position or reputation.
- 14. Schedule 2 Specified Matter (Clause 8.3)
 - Addition of paragraph M to include a serious or systemic confidentiality, privacy or data breach.
 - Consequential lettering changes to paragraphs N to T.
 - Amendment to paragraph T to remove paragraphs H, I, K.
 - Addition of paragraph U to include any other matter which adversely affects or could reasonably be expected to adversely affect the conduct of legal aid work or Legal Aid Queensland's financial position or reputation.
